



Limited Warranty – Garage Screen Components

LIMITED LIFETIME WARRANTY:

The aluminum frame is warranted for life, if properly used and installed, to the original consumer purchaser, to be free of defects in material and workmanship, ordinary wear and tear excepted.

LIMITED TEN YEAR WARRANTY – COMPONENTS:

Component parts, **excluding rollers and screen**, are warranted for a ten (10) year period commencing from the date of sale to the original consumer purchaser as long as he/she owns and resides in the home in which the products were installed and provided instructions for care are followed. This warranty is not transferable and ensures only to the benefit of the original consumer purchaser.

LIMITED FIVE YEAR WARRANTY – DELUXE ROLLERS:

Deluxe rollers are warranted for a five (5) year period commencing from the date of sale to the original consumer purchaser as long as he/she owns and resides in the home in which the products were installed and provided instructions for care are followed. This warranty is not transferable and ensures only to the benefit of the original consumer purchaser.

COVERAGE OF WARRANTY:

The obligation of Custom Window Systems, Inc. under this warranty shall be limited to repair or replacement of any warranted parts found to be defective within the applicable period described above and in accordance with terms and conditions described elsewhere herein.

LIMITATIONS OF WARRANTY:

This limited warranty does not apply to any damage caused by or the result of improper handling, installation, operation, maintenance, accident, fire, natural disaster, explosion, abuse, vandalism or other external forces. This warranty shall be null and void if harmful solvents are used to clean the screen, the frame and/or sash component or if the frame and/or sash component are painted or coated in any way. **THERE IS NO WARRANTY ON SUNSCREEN OR ANY OTHER TYPE OF SCREENING MATERIAL.**

This limited warranty is made in lieu of all other express warranties and extends only to the original consumer purchaser. In no event shall Custom Window Systems, Inc. be liable for special, punitive, indirect, incidental, or consequential damages or losses the consumer may

suffer or incur in connection with this product or its use or for any delays in performance of this warranty due to circumstances beyond its control. Any warranties implied by law, including those of merchantability and fitness for use or for a particular purpose are limited in duration to the express warranties herein.

Some states do not allow limitations on how long an implied warranty lasts; and some states do not allow the exclusion or limitation of incidental or consequential damages or the limitation of remedies for a breach of warranty, so the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights, and you may also have other rights that vary from state to state.

CLAIMS PROCEDURE:

If a warranty claim should become necessary, the original consumer purchaser should contact the **INSTALLING DEALER**. No person, firm or corporation is authorized to alter or change the above warranty or to impose any other liability on Custom Window Systems, Inc.

TAKING CARE OF YOUR GARAGE SCREEN ENCLOSURE:

Custom Window Systems, Inc. has designed your product to require little maintenance. Clean your tracks frequently keeping them free from sand and debris will greatly increase the life of your rollers. **DO NOT** lubricate your rollers as this attracts and holds sand. You may clean your enclosure with mild soap and water. **PLEASE NOTE:** Screen can be easily punctured or cut. Remove all jewelry from your hands and arms before cleaning your enclosure.
